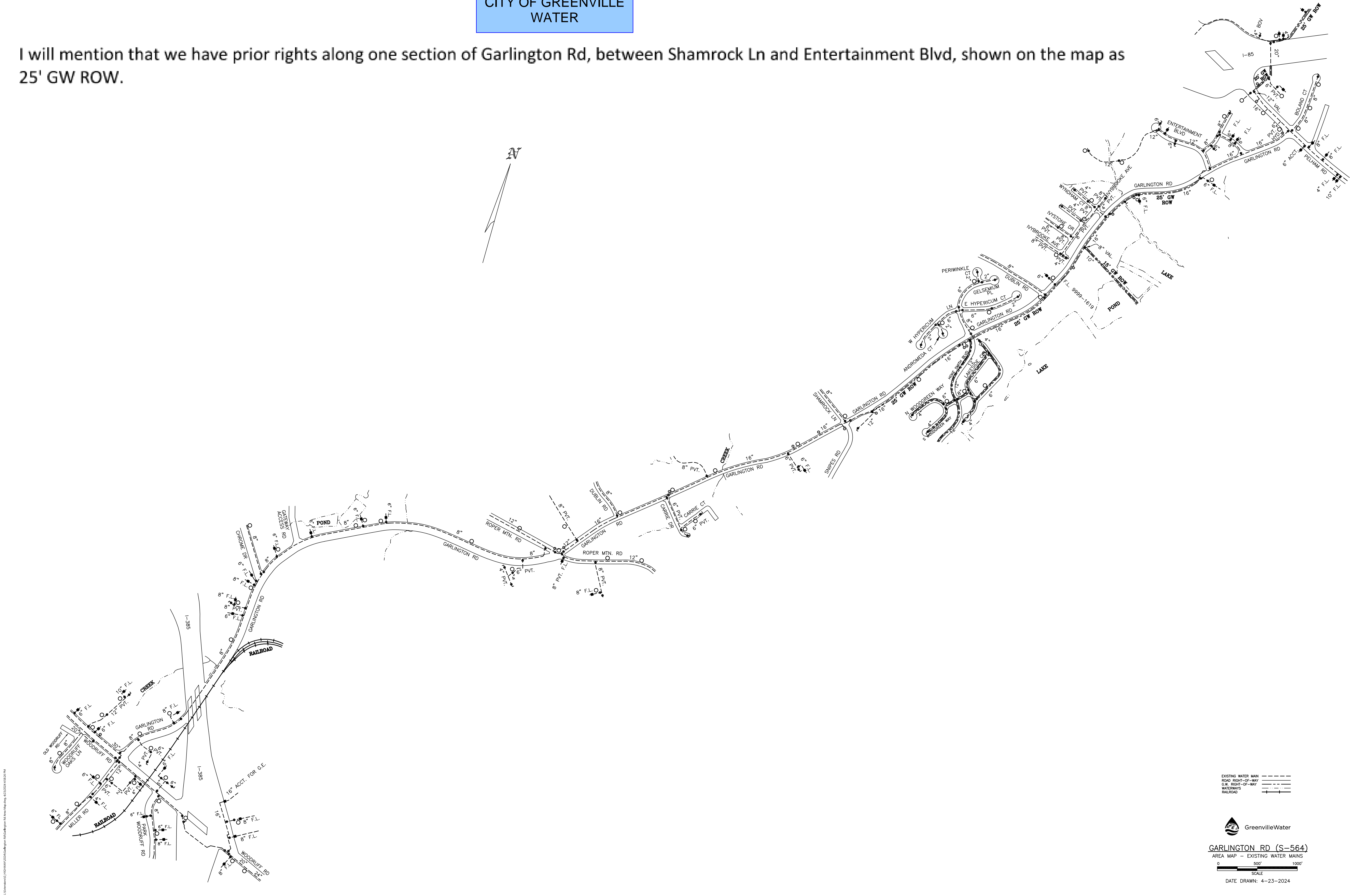

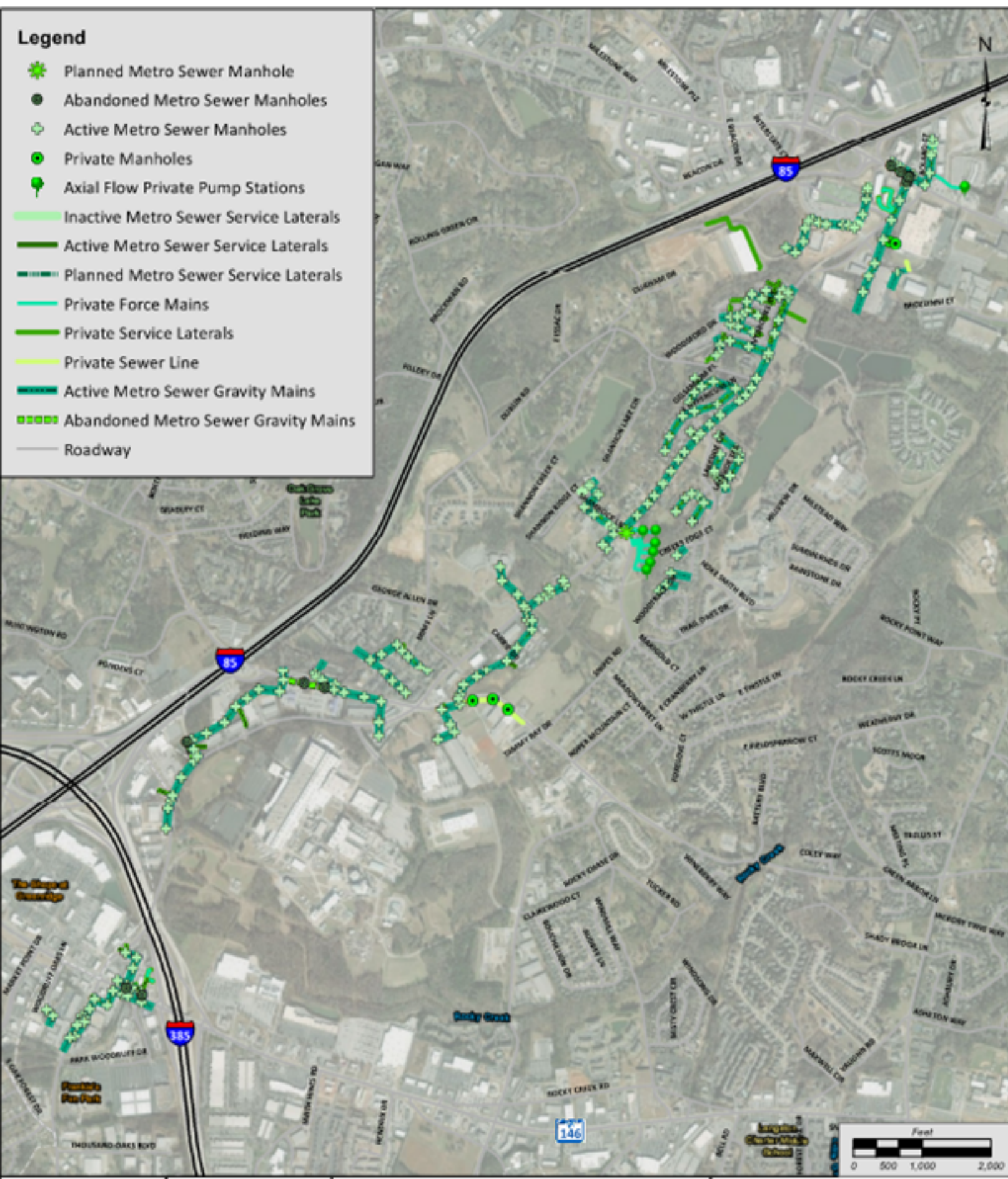

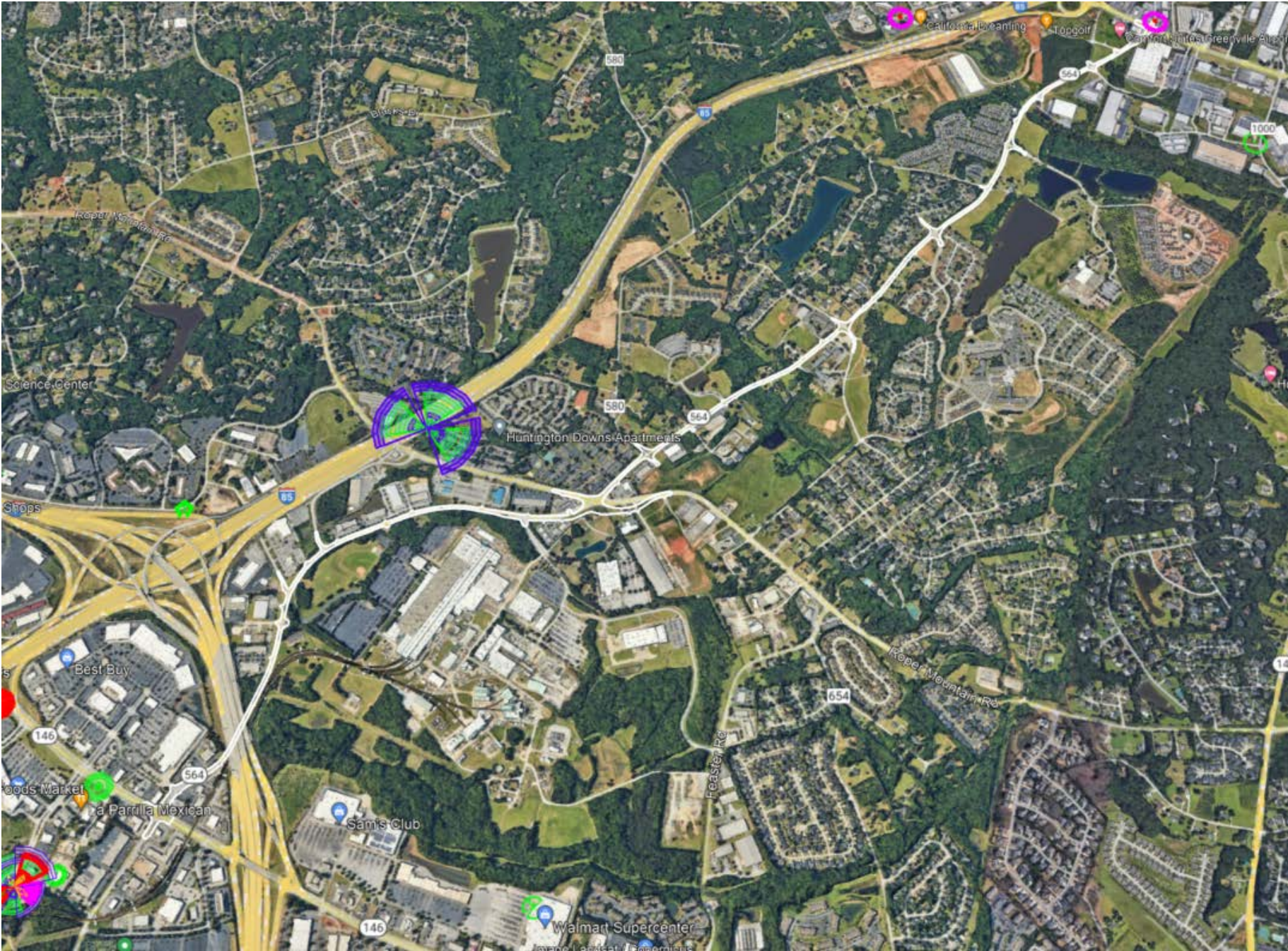

I've looped in David Corder with Verizon as well since it looks like this proposed area would definitely have an impact on the 1Fiber from VZB in the area if it were to be constructed



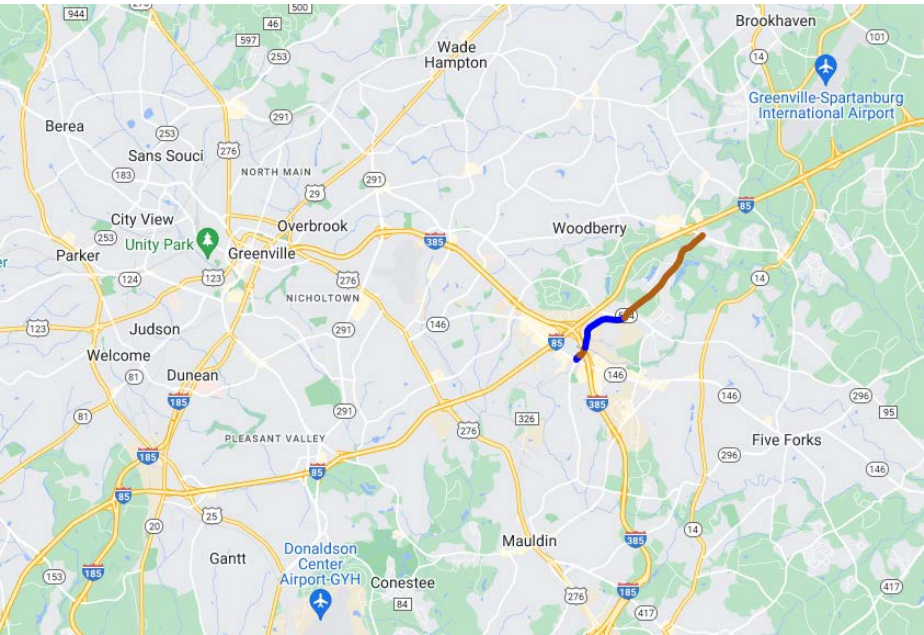
